 - Catering/ Green Room on performance weekends
- Pay in the TYB office (may be called in 919-932-2676)

ATTENDANCE

- Mandatory attendance at all rehearsals and performances
- Missed rehearsal or performance = withdrawal from the show
- Have pre-existing obligations? Please do not accept a role
- Rehearsal times announced weekly on the website

REHEARSALS

- Rehearsal times posted each week by role
- Basic rehearsal schedule provided for planning purposes
- Parents should arrive by the posted end of rehearsal times

PARENT TASKS

 - Use gel and hair spray for a professional appearance
 - Bobby pins in an X formation secure all headpieces
- Party Girls provide their own curls

- Shoes & tights purchased by each dancer
- Shoe & tight requirements will be provided for each role on website

STAGE MAKE-UP

- Dancers are expected to wear stage make up
